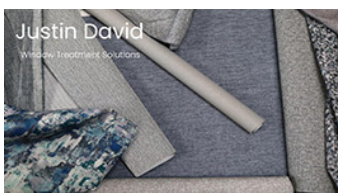

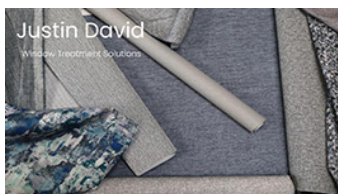

Hi Wendy,

A couple of questions and updates below:

- Is the pricing attached the same for the full production as well?
- Please see the email attachment from Nick who has provided the address and his number as he is the site contact. There are also directions for visitor sign in and parking
- For clarification on the schedule, see below; Does this help answer your question or do you need more clarification? If you need to reach out to Nick directly, that is fine, or I am happy to put everyone in an email thread as needed

The "field measurement of glazing" referenced on the schedule is for the shower doors not the exterior windows.

Regarding the window returns and field measuring for these window treatments. During our demo phase, I made the decision to keep the existing window returns to save on drywall finishing. If I'm able to get the spec's on the flooring/underlayment, could you field measure the curtains with these existing returns?

Looking at the window section detail (4/A621) the current (existing) height will be maintained with the soffit extension. This is where your track is shown to mount.

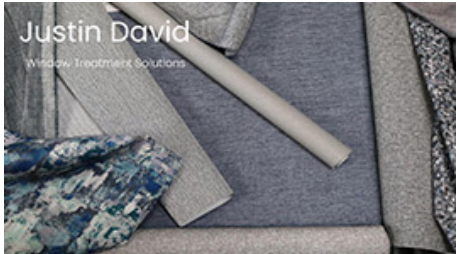

Thank you for sending over the construction schedule. I recommend scheduling the field measure immediately following #33 Drywall finishing of ceilings and soffits. Finished flooring is not required to be installed, but we will need the specification for it, as well as any type of underlayment being installed so that proper deductions may be taken. That being said, can you please clarify what #46 Field measure glazing entails? It sounds like the windows are being changed, but I do not see the installation of them referenced on the schedule so I am a little confused here.

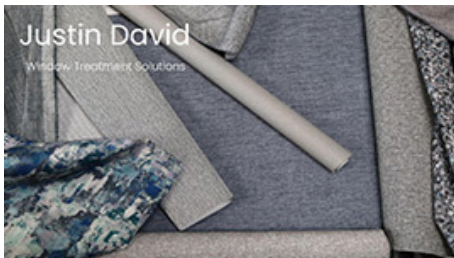

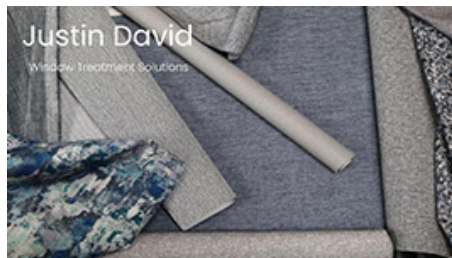

Hi Ashley,

My apologies for the delay. I was hoping to send the revised quote to include the metal batons and self-lined sheers, and revise this yardage at the same time, but that is still in the works as the baton sample will be delivering until Friday to the NY address provided. It is actually a brushed brass finish as we are unable to provide polished brass. Our metal batons are aluminum with a finish to achieve various metal effects, not solid brass, so the polished effect cannot be achieved by this method. Hopefully our brushed brass option will work for the project.

Meanwhile, I know you need to get the fabrics on order, so here are the revised quantities based on the updated specifications...

**F-FA-30/UPH-11:** 118 yards + 13 yards = 131 yards total @ 54" wide. **PLEASE CONFIRM 54" WIDTH IS CORRECT AS THE SPEC DOES NOT INCLUDE THE FABRIC WIDTH**

**F-FA-31/UPH-10:** 59 yards + 7 yards = 66 yards total @ 110" wide

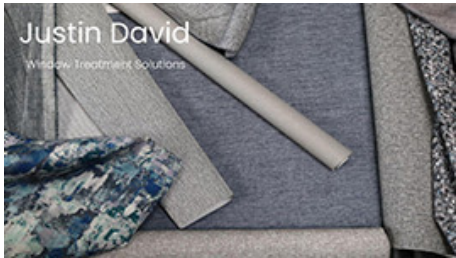
