Within the body of the purchase order are the required quantities. This order must ship complete. Partial shipments are not acceptable without prior written authorization from Travel + Leisure Operations, Inc. (T+LO).

T+LO will not accept overages on fabrics, wall covering and flooring in excess of 5%, unless previously authorized, in writing, by the procurement representative.

Vendor must follow the shipping instructions provided by the procurement representative. Failure to do so may result in vendor having to absorb a difference in price. All items must be packed appropriately to prevent breakage/damage.

All packaging/cartons for the items on this purchase order must be side marked, identifying the job name, purchase order number, and product description, as indicated on each line item of the purchase order. A packing list must accompany the shipping BOL. The packing list must contain the job name, purchase order number, and product description, and product quantity as indicated on each line item of the purchase order.

The purchase order number must appear on all invoices and all invoices must match the purchase order item numbers, quantity, and price for prompt payment.
