Room darkening shades are not blackout shades unless side channels are added. With side channels there is still a possibility of light leakage. OVERSIZED shutter panels may require them to be lifted into the window due to size. LARGE roller shades have a tendency to have ripples in the fabric. This is normal.

Unfortunately we are dependent upon our suppliers to help us meet anticipated delivery dates.
